



FULL PRIZE TERMS AND CONDITIONS

PIE4PTSD 2026 – State of Origin III Prize Draw

1. Promoter

The promoter of this promotion is Emerge & See Ltd (ABN: 29 647 964 305), an ACNC-registered Australian charity, of 48 Russell Street, Oatley NSW 2223 ("Emerge & See", "we", "us").

2. Eligibility

This promotion is open to residents of all Australian states and territories aged 18 years or older at the time of entry, subject to Clause 7.

The following persons are not eligible to enter:

- Employees, officers, directors, or contractors of Emerge & See or any associated organisation involved in administering this promotion
- Volunteers of Emerge & See, regardless of their role or level of involvement in this promotion
- Immediate family members of any of the above

To be eligible, participants must:

- (a) Register for the PIE4PTSD 2026 campaign and raise \$500 or more in verified donations by 11:59pm AEST on Thursday 2 July 2026; or
- (b) Make a direct donation of \$100 or more to the PIE4PTSD 2026 campaign during the Entry Period.

Each eligible participant or eligible donation transaction constitutes one (1) entry into the draw.

For clarity:

- Registered fundraisers receive one (1) entry once their verified fundraising total reaches \$500 or more by the close of the Entry Period.
- Donors receive one (1) entry for each individual donation of \$100 or more made during the Entry Period.
- Multiple entries are permitted, provided each entry independently satisfies the eligibility criteria above.



3. Entry Period

The Entry Period for this promotion opens at **12:00am AEST on Wednesday 27 May 2026** and closes at **11:59pm AEST on Thursday 2 July 2026** ("Entry Period").

Both entry pathways — fundraising and direct donation — are open for the full duration of the Entry Period. Only fundraising totals verified by 11:59pm AEST on 2 July 2026 will count toward the \$500 eligibility threshold.

The PIE4PTSD 2026 fundraising platform may continue to accept donations after the Entry Period closes. Any donations received after 11:59pm AEST on 2 July 2026 will not be counted toward entries in this prize draw and will not constitute an entry, regardless of when they are processed.

Entries received outside the Entry Period will not be eligible. Emerge & See accepts no responsibility for late, lost, incomplete, or misdirected entries.

4. Prize Details

One (1) prize will be awarded, valued at approximately \$2,700 AUD in total, comprising:
